All bidders shall furnish a five percent (5%) bid bond on any contract exceeding \$30,000: provided that bonding is available for services, equipment or materials. Bid bond will be accepted in the form of a certified check, cashier's check, postal money order, etc. Out of State Corporations shall furnish a Certificate of Authority to transact business in the State of Alabama. Out of State limited liability companies shall show proof of registration to transact business in this state. Alabama law requires that a successful bidder, if it has employees in the State of Alabama, provide proof of enrollment in E-Verify prior to the award of a contract. 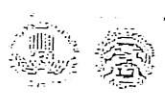

## Specifications

### Mobile County Metro Jail

1. The County of Mobile reserves the right to reject any and all bids, and to waive all formalities. The County also reserves the right to cancel the contract at any time the service or products prove unsatisfactory in the opinion of the Mobile County Commission, the Sheriff of Mobile County, the Chief Clerk, or the Metro Jail Warden.
2. The award of this contract will be made to the low formal responsible bidder as determined by the Sheriff of Mobile County, the Chief Clerk, the Metro Jail Warden, and the Mobile County Commission.

### **Quality and Quantity**

3. All garments must conform to the attached specifications in all respects.
4. The successful bidder will be required to submit samples of the products they propose to furnish, which must be approved by the Mobile County Sheriff's Office Metro Jail Division before a contract can be made, and any deviation from any sample approved by the Mobile County Sheriff's Office, Metro Jail Division, without the express permission of the Mobile County Sheriff's Office Metro Jail Division in writing, will be cause for canceling the entire contract.
5. In case of conflict in the language of said proposal and/or specifications and this contract, the terms and conditions of the contract will be final and binding on both parties hereto.
6. The supplier of inmate uniforms will bill the Mobile County Commission for articles of uniform clothing purchased, delivered and accepted by the Mobile County Sheriff's Office Metro Jail Division.
7. Orders will be filled within 90 days after receipt of purchase order. If orders are shipped in partial increments, payment may be delayed until the purchase order is received in its entirety.
8. The bid award will be for a term of three (3) years.

Materials: Industrial Laundry Finish Fabric, 7.5 oz. twill  
65% Polyester / 35% Cotton  
Sewn with TEK-60 Polyester thread and 26 gauge woven elastic

Shirts: Non-binding 'V' Neck, cut no deeper than 7.5" from top of neck to bottom of 'V'.

Stenciling: Shirts are to be stenciled with the words "Mobile County Metro Jail" in 2" letters on the back upper quadrant. Khaki and White shirts are to be stenciled in black lettering and all other colors are to be stenciled in white lettering.  
  
Pants are to be stenciled with the words "Mobile Co Metro Jail" horizontally on the left pant leg. Khaki and White pants are to be stenciled in black lettering and all other colors are to be stenciled in white lettering.

Equipment: Inmate Coveralls

Construction: Industrial grade twill fabric 65% Polyester/35% Combed Cotton Thread is to be the same color as the fabric.

Construction: Coveralls to be constructed with raglan short sleeves. There shall be an elastic back with woven heat resistant 1-1/2", 26 ga. elastic. Coverall be of one piece construction with no metal parts (snaps, zipper, hooks...). However, plastic zipper or hook and loop are acceptable. Triple needle stitch. All seams shall be cleanly finished and have no raw or frayed edges.

Color: Orange, Green, Blue, Pink

Stenciling: The words "Mobile County Metro Jail" are to be stenciled on the upper quadrant of the back of the coverall in black lettering.
