Established:

The Board of Commissioners of Mobile County, Alabama (now known as Mobile County Commission) adopted a resolution that authorized the formation of the Kushla Water and Fire Protection Authority in its regular meeting on March 11, 1974. The Board of Commissioners of Mobile County, Alabama, adopted a resolution on March 27, 1995, approving the amended Certificate of Incorporation to change the name of the Kushla Water and Fire Protection District to Kushla Water District.

Purpose:

To deliver safe drinking water to the citizens of Mobile County residing within Kushla Water District's service area.

Board Members:

The Board consists of eight (8) members. Six (6) members are appointed by the Mobile County Commission, one (1) member is appointed from the City of Saraland, and one (1) member is appointed from the City of Prichard. All members must be residents who own real property within the service area and are qualified voters.

Kushla Water District mails announcements of Board vacancies to every subscriber. The Board of Directors interviews applicants and rates them on a point system. The Board of Directors then sends their recommendations to the Mobile County Commission for approval.

Length of Term:

Four (4) years.
