The contractor shall meet all Alabama Department of Transportation (ALDOT) Bonding and Licensing requirements as well as all applicable laws, ordinances, and codes of the U.S. Government, the State of Alabama, any relevant municipality, and the COUNTY, and, specifically and without limitation, shall comply with all provisions of the Beason-Hammond Alabama Taxpayer and Citizen Protection Act, commonly referred to as the Immigration Act. Liquidated damages for non completion of the work within the time limit agreed upon will be assessed in accordance with the terms of the contract.

A pre-bid conference will be held on **MARCH 26**, **2025** at **10:30 AM** Central Time in the Mobile County Engineering Department, Mobile Government Plaza Sixth Floor South Tower Mobile, Alabama. All prospective bidders should have a representative present at the pre-bid conference.

No bids will be considered unless the bidder, whether resident or non-resident of Alabama, is properly licensed and qualified to perform the work described herein in accordance with all applicable laws of the State of Alabama. This shall include evidence of holding a current certificate to engage in general contracting in the State of Alabama, issued by the State of Alabama Licensing Board for General Contractors, Montgomery, Alabama, as required by Section 34-8-2, Code of Alabama (1975). Any contractor that desires to bid as a prime contractor must have at least one of the following major classifications of license per Section 230-X-1-.27 of the State of Alabama Licensing Board for General Contractors Code:

- 1.c.) Highways and Streets
- 1.d) Municipal and Utility
- 1.e) Heavy and Railroad Construction

Out of state corporations shall furnish a certificate of authority to transact business in Alabama. Out of state limited liability companies shall provide proof of registration to transact business in this state. Prior to the award of a competitively bid contract to a contractor having one or more employees in the State of Alabama, Alabama law requires that the contractor provide the County proof of enrollment in E-Verify (see www.uscis.gov/everify).

Sealed bids will be received by the Mobile County Commission at 205 Government Street, 8<sup>th</sup> Floor South Tower, Mobile, Alabama until **10:00 AM** Central Time on **APRIL 2, 2025**, and then publicly opened as soon thereafter as practicable. Award will be made at the next regularly scheduled meeting of the Mobile County Commission.
