Established:

Mobile County Commission authorized the operation of the Senior Companion Program of Mobile County Advisory Council at its regular meeting on October 14, 1980.

The Senior Companion Program of Mobile County Advisory Council is an initiative of the Corporation for National and Community Services (CNCS).

The Mobile County Commission sponsors the Senior Companion Program of Mobile County Advisory Council.

Purpose:

The purpose of the Advisory Council is to assist and advise the Senior Companion Program and SCP staff on matters concerning planning, community support, project policies, and operation issues and to conduct a quarterly and annual appraisal of the program. The project's progress is assessed in relation to the state's stated goals and objectives and the program's effectiveness in the community.

Membership:

The Advisory Council shall include the sponsors, Board of Directors, representatives of public and private community agencies, minority groups, civic and service organizations, volunteer stations, local government, and the business community and organizations concerned with the interests of older persons and voluntarism.

The Advisory Council shall consist of not less than 20 members or exceed more than 25 members.

Names of those to be considered for election to the Advisory Council should be submitted to the Nominating Committee.

Vacancies on the Advisory Council shall be filled within one (1) month to serve the unexpired term of a retiring member.
