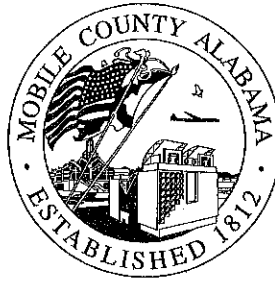

By publicly posting this written notice Mobile County Commission intends to provide certain representations pursuant to Rule 15Ba 1-1 (d)(3)(vi)(B) (the "Municipal Advisor Rule") promulgated by the U.S. Securities and Exchange Commission under the Securities Exchange Act of 1934, as amended (the "Exchange Act"), regarding the participation of our independent registered municipal advisor with respect to providing advice regarding municipal financial products or the issuance of municipal securities.

We are represented by PFM Financial Advisors, LLC ("PFM"), our independent registered municipal advisor (our "MA") registered as a municipal advisor pursuant to the Exchange Act. We have retained our MA to, among other things, assist us in evaluating recommendations relating to the issuance of municipal securities and municipal financial products. Our MA does not represent us with respect to investment of proceeds of municipal securities. We hereby represent that we are represented by, and will rely upon the advice of (i.e., seek and consider), our MA with respect to the evaluation of any and all recommendations submitted to us relating to the issuance of municipal securities or municipal financial products.

We require that all correspondence that includes advice to us respecting the issuance of municipal securities or municipal financial products be provided to our MA prior to, or concurrent with, delivery to us. We have made an inquiry of our MA and we were informed that as of the date of this letter no "Associated Individual" (within the meaning of the SEC Staff's FAQ No. 3.6) of PFM who is anticipated to provide municipal advice to us have been employed by a broker-dealer within the past two years. Verification of independence (as is required under the IRMA exemption) shall be your responsibility as the party seeking to rely on the IRMA exemption.
